«Corruption and anti-corruption policy of the nursery garden» from

11.07.2022 year

Purpose: education, propaganda and formation of an anti-corruption worldview

Objectives: to promote the development of legal consciousness, civic position, the ability to draw conclusions based on the data obtained. fostering a positive attitude to the moral norms that form the basis of a person, raising the level of their legal consciousness and legal culture; an active approach to anti-corruption programs.

Currently, there is a lot of talk about corruption. This problem is often covered in the media, public speeches. Anti-corruption is becoming one of the most pressing tasks and priority areas of legal reform in Kazakhstan. The organization of anti-corruption activities is necessary to combat this phenomenon and should be carried out in all structures, including preschool educational institutions.

According to the Law of 29.12.2021 No. 91-VII «On Combating Corruption», the anti-corruption policy is a set of interrelated principles, procedures and specific measures aimed at preventing and suppressing corruption offenses. Responsible for the organization of work on the prevention of corruption violations have been appointed in the Nursery garden «Tansholpan», as well as a commission for the prevention and combating of corruption has been established. This commission was created to solve a number of tasks facing it: participate in the development and implementation of priority areas of anti-corruption policy in the nursery:

- coordinate activities to eliminate the causes of corruption and conditions conducive to them, identify and suppress the facts of corruption and its manifestations;
- make proposals aimed at implementing measures to eliminate the causes and conditions that contribute to corruption in the nursery;
- develop recommendations for practical use in the prevention and prevention of corruption offenses in the activities of the nursery;
- interact with law enforcement agencies in order to implement measures aimed at preventing (preventing) corruption and identifying subjects of corruption offenses.

At the beginning of the school year, a plan of anti-corruption activities is being developed in the kindergarten, the purpose of which is to create, as well as introduce legal and organizational mechanisms, psychological and moral atmosphere, which are aimed at full-fledged prevention of corruption in preschool institutions. The plan involves work in the following areas:

- organizational arrangements;
- introduction of the institute of public control and involvement of citizens, civil society institutions in the implementation of the Anti-Corruption Strategy;
- informing the population about the facts that have a corruption component in the field of education;



- legal regulation of the performance of state functions and the provision of public services.

To ensure maximum visibility, we have the material on information stands, and also places it on the website of a preschool educational institution.



Every year, kindergarten staff conduct a survey of parents or legal representatives of pupils, the purpose of which is to determine the degree of their satisfaction with the services provided by the kindergarten, as well as to check the quality of their provision.

The results are posted on the official website of the nursery garden. Work requires conscientiousness, honesty, kindness - all this is the key to our success. The actions and behavior of each

participant in the educational process are very important for achieving good work results. The constant development of our activities requires from all of us coherence of actions, and that is why the establishment of common principles and values is especially necessary. We are hereby taking the first step towards the systematic implementation of the compliance and anti-corruption program and we expect all participants in the educational process to embark on this path.

- 6) приоритетного применения мер предупреждения коррупции;
- 7) поощрения лиц, оказывающих содействие в противодействии коррупции;
- 8) неотвратимости наказания за совершение коррупционных правонарушений.
